#### SPECIFIC ATION

PUSH CART: Type-push type hand cart with tubular frame, with raised handle bar of 01. width same as cart at a height of approximately 800 mm from base at a maximum angle of 450 to horizontal. It should have two wheel in the front of diameter 250 mm. There should be two side supports ( on the sides of handle) to stand the cart in position. It should have a brake mechanism with lever reaching next to the handle bar to lock vehicle in position, the axle live load should be of 100 kg. The cart should have heavy duty wheels with rubber

Cart- The push cart should have dimensions about 0.98 X 0.68 X 0.255 (1 X b X h) to accommodate 4 bins at one level & should have a sturdy tabular/angular frame, the frame towards the bundle should be raised to a height of 0.6 m with 6mm thick hooks places at 30 cm c/c on top bar to hand bags. It should also have a closed hook of 16 mm rod for securing the cart . The height of the container top level shall be  $0.05\ m + -0.1\ m$ . painting two coat over a coat of primer complete in all respect -Rate per each.
