- The Original Documents only through Regd/Speed post should reach on or before 02.08.2019 up to 5.00 pm and other means of posting are not allowed.
- Bids received on line shall be opened at $\underline{03.00PM}$. on $\underline{Dt.\underline{03.08.2019}}$ in the Office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the Office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- After the date and time of receipt of bid is over, the original Bid security and Demand Draft/ Bankers Cheque / postal plegged towards cost of Bid documents shall be submitted in the Office of the undersigned on or before date and time of opening of Bid as specified at Para 06 above, during Office hours on working days failing which the bid will be rejected.
- The cost of bid documents in shape of demand draft/bankers cheque issued from / postal plegged and any Nationalized / Scheduled commercial Bank may be prepared in the name of the Executive Officer, Koraput Municipality mentioned under Col.7 above payable at headquarter of Koraput Municipalityseparately i.e. towards paper cost of each Bid respectively.
- 10 Additional Performance Security shall be obtained from the bidder when the bid amount is less then estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e estimated cost put to tender minus the quoted amount as Additional Performance security (APS) in shape of Demand Draft/Term Deposit Recepit pledged in favour of the Executive Officer within seven days otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for blacklisting shall be initiated against bidder.
- If the rate quote by the bidder is less than 15% of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalized the tender through a transparent lottery system, where all bidders /their authorised representatives, the concerned Executive Engineer and DAO will remain present.
