Criteria for Evaluation:

- The Self Help Group must have an annual turnover of minimum 3 lakhs per annum for last 3 years consecutively.
- The Self Help Group must have not been involved in any financial irregularities such as loan declared as NPA, Pre-settlement or one time settlement of loan etc.
- The Self Help Group members should not have record of involvement in any anti-social activity.
- The Self Help Group belong to the same ULB where the Aahaar Kitchen is operational / going to be set up may be given preference.
- 7. The Self Help Group having experience in similar kind of activities may be given preference.

Submission of Expression of Interests

The Self Help Group shall submit their EOI as per the formats in Annexure - I & II along with photocopies of all the supporting document and should be covered with Seal and details of SHG with Phone No. And clearly super scribed as "EOI for Selection of Mission Shakti Group for O & M of Aahaar Kitchen".
